The following business was transacted:

Item 1.

To discuss about submission of annual renewal documents and approval of IAA Constitution/Bye-laws with Registrar of Society Office, Varanasi.

Resolved to submit necessary IAA registration-related documents to the Registrar of Society Office, Varanasi, through Advocate H. R. Gupta and approved advocate professional fees of Rs. 25,000/-.

It is further resolved that the IAA Present Constitution/Bye-Laws, which were approved in the Gwalior meeting, are to be got approved with the Registrar of Society Office, Varanasi, for said task, services of Advocate H. R. Gupta are to be hired, and whatever expenses (approximately Rs. 1,25,000) are incurred related to it, are approved.

Item – 2

Discussion about GST.

Resolved to discuss the issue of GST in the Executive Committee Meeting to be held at Kolkata.

Item – 3

Implementation of Journal Management System.

Prof. Gabriel Simon Thattil and Dr. Nimmi Dev, Chief Editor of IJA, have presented details about the journal management system of Qtanalytics. It was resolved to implement this journal management system in the next issue of IJA, and expenses related to it were approved. (Rs. 5,000 installation charges, Rs. 18,000 Annual charges, and Rs. 125 DOI charges per article.)

Item – 4

Norms for posting messages in IAA WhatsApp Executive Committee Group.

The IAA WhatsApp Executive Committee Group was created to post messages related to IAA only. So it was resolved that group messages should be posted through admin only. Prof. J. K. Jain – Joint Secretary, is authorized as group admin, and any member who wants to post a message in the group has to send a message to Prof. J. K. Jain, and he will decide and post the message in the group.
